

Terms and Conditions for Showmax Entertainment Free Trial

Introduction

These Terms and Conditions govern the Showmax Entertainment 30-day free trial and promotion for select and active DStv South Africa customers to sign up for Showmax Entertainment and add it to their DStv bill at no cost for one month. The following terms outline the conditions required for eligibility and participation in the promotion.

Eligibility

- The Showmax Entertainment 30-day free trial is open only to selected and active DStv South Africa customers.
- Participants must be active DStv Compact Plus, Compact, Family, or Access, customers who do not have Showmax Entertainment added to their DStv bill.
- Participants must have their DStv and Showmax subscriptions active throughout the Showmax Entertainment 30-day free trial month.

Ineligibility

- Customers who have a disconnected DStv package subscription.
- Customers with a DStv Premium or DStv EasyView subscription.
- Customers who have participated in the free trial previously, will not be eligible for the offer.
